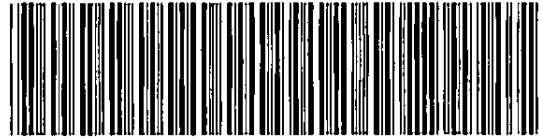




1. The name of the "Other Business Entity" immediately prior to the filing of these Articles of Conversion is Loud And Live Management Group, Inc.

**ARTICLES OF ORGANIZATION  
OF  
LOUD AND LIVE MANAGEMENT GROUP, L.L.C.**
